Did you know:

- ✓ A study by the U.S. Government Accountability Office found that schools with high levels of deferred maintenance had 12-15% lower student test scores
- ✓ Researchers at the 21st Century School Fund determined that schools deferring maintenance were 20% more likely to have poor indoor air quality, leading to higher rates of student and teacher absenteeism due to health issues
- ✓ A report by the National Center for Education Statistics indicated that teachers in schools with significant deferred maintenance were 18% more likely to report job dissatisfaction and burnout, negatively impacting student learning.
- ✓ Researchers at the University of Tulsa determined that students in classrooms with higher levels of illumination (500-600 lux) scored 7-12% higher on standardized tests than students in classrooms with lower light levels (300-400 lux).
- ✓ A study by the National Center for Education Statistics showed that students in schools built before 1960 had 12% higher rates of absenteeism compared to students in schools built after 1990, likely due to poorer building conditions and environmental factors.

## State Legislative Update

A FY 2025-2026/2026-2027 operational budget was approved by a simple majority on the legislature on March 21, 2025. Despite the legislative adjournment, the Governor called the legislature back into session to finish their work on pending bills. A list of bills that would be of interest to MeASBO members is posted under the “Recent News” section of our [website](#); this list is updated at least weekly. If you have not had an opportunity to do so, please review [LD 1400](#), “An Act to Exempt Certain Public School Districts and Their Employees From the Paid Family and Medical Leave Benefits Program”, as well as [LD 1518](#), “An Act to Clarify the Amount and Use of Unallocated Balances in a SAU Budget”.

Remember, due to our 501©3 status, MeASBO is unable to advocate on legislation however, if you would like to submit testimony but feel unsure about how to communicate to a legislative committee, reach out to [Joanne](#) for tips and tricks.

## 2025-2026 Membership Update

As many school unit members are in the process of creating budgets for next fiscal year, MeASBO’s Board of Directors met to discuss next year’s school unit membership dues and has approved an annual membership dues increase of 5% for individual school unit memberships and district memberships. This will equal \$262 and \$525, respectively, for the 2025-2026 fiscal year. Vendor memberships for next year have not undergone Board review at this time; an update will be provided to vendor members as soon as that review has taken place.

### Federal Updates:

Impact of Executive Order to Dismantle USDOE - The Executive Order (EO), entitled, "Improving Education Outcomes by Empowering Parents, States, and Communities," asserts that federal programs and dollars have failed our nation's children, teachers, and families and that closing USED would "provide children and their families the opportunity to escape a system that is failing them." It claims USED's main functions can, and should be, returned to the states.

Executive orders are not law, they cannot create new laws; they are constrained by existing law. As always, districts should consult with their legal counsel to determine how to comply with current law and navigate potential changes in the future.

Section 2 of the EO reads:

- (a) The Secretary of Education shall, to the maximum extent appropriate and permitted by law, take all necessary steps to facilitate the closure of the Department of Education and return authority over education to the States and local communities while ensuring the effective and uninterrupted delivery of services, programs, and benefits on which Americans rely.
- (b) Consistent with the Department of Education's authorities, the Secretary of Education shall ensure that the allocation of any Federal Department of Education funds is subject to rigorous compliance with Federal law and Administration policy, including the requirement that any program or activity receiving Federal assistance terminate illegal discrimination obscured under the label "diversity, equity, and inclusion" or similar terms and programs promoting gender ideology.



Section 3 part (b) also includes the same language that's in all other EOs, "This order shall be implemented consistent with applicable law and subject to the availability of appropriations."

This Associated Press penned an article about the executive order summarizes what the EO does and doesn't mean for schools: The Department isn't set to close completely, it will retain certain critical functions such as preserving its responsibilities for Title I funding, Pell grants, IDEA funding, and managing federal student loans. Even in light of recent reductions in force at USED, the agency assured state school chiefs in a March 14 letter that "critical functions for elementary and secondary education will not be impacted by these cuts." This EO will be challenged in court, as well as in Congress. Teacher unions have already signaled they will file a lawsuit against the order, and there is not enough support in Congress to pass legislation to close the Department. Even if a bill passed the House, it would require 60 votes in the Senate to pass (in order to break a Democratic filibuster), and no Democrats support closing USED.

There isn't a lot of clarity on what USED functions would be delegated to other agencies if the White House chose to reorganize or shift programs around. USED plays a big role in civil rights enforcement in schools, and the Trump Administration has relied on USED to promote education priorities in their agenda, including investigating discrimination based on race and for threatening to withdraw federal funding from schools and colleges that promote "transgender ideology" or "illegal DEI" activities. The administration's anti-DEI EOs are also being challenged in court due to lack of clarity on what constitutes illegal DEI activity as well.
